Whenever you are depositing a check via our Mobile Deposit Capture, please make sure you have done the following PRIOR to capturing a picture of the check.

- 1. Please sign the back of your check.
- 2. Please write out your account number underneath your signature.
- 3. "For mobile deposit only" written out in that exact wording.

Please do not destroy your check until the deposit has been confirmed. If you don't know your account number - you can find it in your mobile app or contact us for assistance.

GET YOUR TAX RETURN FASTER

Save the time and hassle of depositing a check and get your tax refund sooner by depositing it directly into your B-M S FCU account! All you need to do is provide your B-M S FCU account number and our routing number (221277007) on your tax return.
